International Pipe Inspectors Association Membership Terms and Conditions

1. Full Members may cast one (1) vote at the Annual General Meeting for the election of the Board of Directors.
2. Full Members may present, second, debate, and vote on motions made at the Annual General Meeting.
3. Full Members may enter agenda items at scheduled Board of Directors Meetings.
4. Full Members may attend scheduled IPIA courses at the established member rates.
5. Full Members may advertise in the IPIA quarterly newsletter - Crosstalk at the established member rates.
6. Full Members may obtain available support on OCTG by phone, fax, or email. Consulting fees may be charged if a matter cannot be resolved by normal support procedures.
7. All invoices are due and payable upon receipt.
8. Invoices, Statements and Account Notices may be sent by mail. When any of these documents is sent by email or fax it is considered to be an 'original' document.
9. All charges are payable in U.S. currency, by Cashiers Check, Wire Transfer, Money Order or Company Check. All amounts due are NET to IPIA.
